**ORDER**

Government of India (GoI) granted 'In-principle' approval to Government of Goa for setting up of Greenfield airport at Mopa in Goa through Public Private Partnership (PPP). Government of Goa has signed Concession Agreement with GMR Goa International Airport Limited (GGIAL) for construction of Greenfield International Airport at Mopa in Pernem taluka on 08.11.2016.

2. In terms of the Concession Agreement, Government of India has entered into an Memorandum of Understanding (MoU) with M/s. GMR Goa International Airport Limited (GGIAL) on 31<sup>st</sup> March, 2017. As per Clause 4 of the MOU, a Joint Co-ordination Committee(JCC) is hereby constituted with following composition, to ensure smooth and efficient rendering of the Reserved Services.


